State Meet –

- Facility –
 - Have not heard yet about alternate dates.
 - Could do Father’s Day weekend – but probably no stalls.
 - Memorial Day Weekend – Deschutes County 4-H Horse Show – could maybe bump and use this date.
- Stalls –
 - Need about 625-650 stalls for state meet.
 - We rent 225 stalls.
- Options –
 - Cancel the meet now.
 - Wait until May with current dates.
 - Push out to late May or June.
- Discussions –

- Judges contracts –
 - Can we put a clause in the contract to reflect the situation?
- Need to hold out for as long as possible.
- Don't want to get hopes up and then not have it.
- Financial aspects is/are going to be real for parents –
 - How can we help those that need it?
 - Cash in one of our CDs to help pay for stalls.
- Stalls –
 - Discussion on how to get extra stalls from various other facilities if needed.
- Options –
 - Want to proceed with meet? Yes.
 - Dates –
 - May 10th date (original)
 - Memorial Day Weekend (30th – 31st)
 - Father's Day Weekend (June 13th – 14th)
 - Discussion on the options listed above.
 - What about those districts with only one meet completed?
 - Only allow 2 meets (let those have their 2 meets and only have 2 meets for the season points).
 - Straw Poll –
 - Memorial Day weekend was the chosen date(s).
 - Father's Day weekend would be 2nd choice.
- Other –
 - If school cancelled for the year – no state meet.
 - If school closure is pushed out after April 28th – no state meet.
 - Denise will get costs of the state meet to Candi.
 - State Raffle –
 - Get those tickets sold – get creative in selling!!
 - Get all sold raffle tickets to Carolyn by April 20th.
 - Keep those not sold and keep selling!!
 - All tickets need to be to Carolyn by May 1st.
 - Need to make arrangements to get tickets to Carolyn –
 - Mailing is fine with tracking.
 - UPS.
 - Personally – with 6ft social distancing!
 - Corinne motioned to use whatever accumulated points an athlete has from 1 or 2 meets to qualify for the state meet. Sherri seconded the motion.
