Co-Ops -

- Standard
 - o Central -
 - Hermiston HS with 6 riders.
 - Riverside HS with 1 rider.
 - All forms signed by both schools. Riverside will not support a team.
 - Central has approved the co-op.
 - Christina motioned to approve the Standard Co-Op between Hermiston HS and Riverside HS. Kevin seconded the motion.
 - No additional discussion.
 - Vote: 13 Yes, 0 No, 0 Abstain. Motion passed. (4 Voting members had not joined the meeting yet.)
- Non-Standard
 - o Willamette -
 - Newport HS with 4 riders.
 - Siletz HS with 2 riders.
 - Co-op forms signed by both schools. Siletz will not support a team.
 - Non-standard because Willamette is requesting conditional approval from the State Board. Final approval is pending when Willamette has their next district



- meeting to vote on the co-op. Co-op will be approved once all the required paperwork is received by the Co-Op Chair.
- Christina motioned to approve the conditional above-mentioned non-standard co-op. Sherri seconded the motion.
- No additional discussion.
- Vote: 17 Yes, 0 No, 0 Abstain. Motion passed. This co-op is conditionally approved – will be final once all the required paperwork is received by the Co-Op Chair.

Eligibility -

- Central
 - o Redmond HS.
 - Athlete is a sophomore.
 - Would like an exception to participate this season while not OSAA eligible due to "not on track to graduate" and insufficient credits at the end of last school year.
 - Athlete has passed all classes for the first trimester of this year, is retaking classes, and taking additional core classes to make up credits.
 - Redmond AD sent letter in support of athlete, Redmond HS teacher sent letter supporting the exception (has 2 classes with athlete), and letter from family.
 - Christina motioned to allow this exception for the athlete to participate this season (2022-2023) with Redmond HS. Heather Z seconded the motion.
 - Discussion
 - The AD shared information but would not support an OSAA hardship/exception if this was an OSAA sport.
 - The athlete has raised her grades slightly, but still continues to struggle a bit.
 - O Vote: 0 Yes, 17 No, 0 Abstain. Motion failed.

Central –

- Culver HS.
- Athlete is a Senior.
- Would like an exception to participate this season while not OSAA eligible due to "not on track to graduate" and insufficient credits earned at the end of last school year.
- Athlete is currently taking 7 classes and passing all of them, is ahead of the graduation plan that Culver HS set up and is completing online classes to gain extra credits.
- Culver AD sent a letter in supporting the exception (Note: Culver would support an OSAA hardship if she was in an OSAA sport.)
- Culver OHSET coach/advisor sent email supporting the exception.
- o Letters received from the athlete and the athlete's family.
- Heather Z motioned to approve this eligibility exception for this season (2022-2023). Christina seconded the motion.
- Discussion
 - The AD is very supportive of the athlete.
 - The athlete is ahead of the agreed upon plan for getting caught up.
- Vote: 17 Yes, 0 No, 0 Abstain. Motion passed.

- Sherry motioned to accept both of the above-mentioned minutes. Sheryl seconded the motion.

Treasurer -

- Denise had emailed reports and proposed budget out prior to the meeting.
- Proposed budget
 - Online QuickBooks is a new budgeted item.
 - This is a big expense but is necessary to have transparency within the organization.
 - All districts will be using online QuickBooks starting July 1, 2023.
 - Get a 50% discount for the first year \$3000. Will go up the following year.
 - This allows the state treasurer to run quarterly reports, have access to district books, and the ability to do "spot checks".
 - May have some licenses for some teams but not sure yet.
 - Will have a training session for all district treasurers prior to the implantation of the new QuickBooks. Denise will schedule and run this.
 - Mileage fee to \$.63 a mile (passed at a previous meeting).
 - Background checks \$2030 (passed at a previous meeting).
 - Have the state and district treasurers bonded \$720 (passed at a previous meeting).
 - Sherri motioned to approve the proposed budget for the 2022-2023 season. Sheryl seconded the motion.
 - No additional discussion.
 - O Vote: 17 Yes, 0 No, 0 Abstain. Motion passed.
